#### INTRODUCTION

In the 17th edition of the IOPD Award "Best Practice in Citizen Participation", **149 proposals have been submitted** from the following countries:

Argentina, Austria, Belice, Benin, Brazil, Canada, Chile, Colombia, Côte d'Ivoire, Czech Republic, Ecuador, France, Guatemala, Iran, Italy, Jordan, Kenya, Morocco, Mexico, Niger, Peru, Philippines, Portugal, Democratic Republic of Congo, Senegal, Spain, Sweden, Switzerland, Tchad, Togo, Türkiye, United Kingdom, United States of America, Zambia.

This was a remarkable year for the IOPD: our award set a new record of nominations received. This achievement is more than just a number: it is a reflection of the strenuous work of local and regional governments to promote a more inclusive and sustainable participatory democracy with communities in all their diversity, despite the multiple crises we are currently facing in the world.

Moreover, new this year, we have added two **categories** to classify and evaluate the practices submitted. The first one on the most outstanding dimension of the practice: the **deliberation** process, the inclusion and role of citizens in **decision-making** and the centrality in the **citizenship** dimension of the project.

The second dimension refers to the size of the candidate city or region: municipalities with less than 50,000 inhabitants, between 50k and 250k inhabitants, between 250K and 1 million inhabitants. Cities

with more than 1M inhabitants and finally supralocal and regional governments.

The 149 applications received underwent an initial evaluation by a jury to select the 40 finalists. A second, reduced jury deliberated on the award-winning experience and the special mentions.

The main criteria for selecting the winning experiences have been the degree of innovation in its own context, the inclusion promotion, the impacts achieved and the inspiring example to achieve significant transformation from local and regional governments from the hand of the communities.

The Jury decided to grant the 17th IOPD Award to the Ville de Rennes and Rennes Métropole for the experience "European Citizens' Initiative: "Let's ask Europe to give migrants a decent welcome".



A special mention was also given to five other experiences that were highly valued by the jury:

- Special Mention in the Citizenship category: Titibirí: "Weaving Citizenship: Training and Social Support for Democracy, Participation, and Reconciliation."
- Special Mention in the Deliberation category: Fortaleza "Integrated Land Regularisation Planning in Special Areas of Social Interest."
- Special Mention in the Decision category: Rosario: "Participatory Budget 2023-2024: Citizen Laboratories as Innovation Devices in Public Policy Management."
- Special Jury Mention for a Valuable Experience in a Human Rights Violation Context: City of Goma: "University Citizen Program of the Democratic Republic of Congo."
- Special Mention for the Experience Most Supported by the IOPD Community: City of Lipa: "Launch of the 'Trash to Cash' Programme." This experience received the highest number of votes during the open evaluation through the ParticipateOIDP platform.

Through this award, the IOPD honours its raison d'être by offering an opportunity to showcase innovations in local and regional participatory democracy and providing a space for knowledge exchange and peer-topeer learning.

In addition to being highly commended by the jury, the 149 local and regional government practices submitted for the IOPD Award also receive our recognition through this compilation. We encourage all those interested in promoting a stronger, more inclusive and diverse participatory democracy to enrich their practice through this document.

In this publication we present the six awarded experiences and share a brief presentation of all the nominations with links to the platform where you can find further and detailed information on each project.

The IOPD Technical Secretariat expresses its deepest gratitude to all the local and regional governments that took the time and made the effort to submit a nomination. We also thank all the institutions and partners that have supported us to share this initiative and the network's collaborating members who, as the Jury, took part in the evaluation of all of the different experiences presented.



In this 17th edition of the IOPD Award, two groups of juries participated in its evaluation: one for the first phase of evaluation and selection of finalists, and another for the second phase to select the winner and the special mentions among the 40 finalists.

The **first jury** consisted of 21 people and was divided into three groups per category: deliberation, decision, and citizenship. During June, this jury read and evaluated the applications received. Finally, they selected the 40 finalists who moved on to the second phase.

# European Citizens' Initiative: "Let's ask Europe to give migrants a decent welcome"

Ville de Rennes and Rennes Métropole

Citizenship / Between 250.000 and 1.000.000.000 inhabitants

Rennes, capital of Brittany, is known for its economic dynamism, dense associative fabric, quality of life, cultural offer and student life. The city of Rennes (220,000 inhabitants) leads this project together with Rennes Métropole (457,000 inhabitants, 43 municipalities). Nathalie Appéré has been mayor of the city since 2014 and president of the metropolitan government.

The city has been developing processes of citizen participation and local democracy for a long time,



establishing participatory mechanisms to involve citizens in public policies, such as participatory budgets, consultations, dialogue tables, third places, etc.

Rennes also aims to be a welcoming territory for exiled persons. There are many associations that work to welcome and integrate immigrants. They provide legal assistance, access to healthcare, housing, education, etc. Local public authorities undertake to financially support these associations and develop a reception and integration policy at their scale. Rennes Métropole is collaborating with the French State in the matter (Reception Contract and Territorial Integration) and is a member of the ANVITA network: National Association of Welcoming Cities and Territories. It regularly goes beyond its formal competences to help exiled people in its territory, in particular by hosting families at its own expense.

In this context, the experience carried out is based on a European tool: the European Citizens' Initiative (ECI). It is a participatory tool created by the European Commission that allows citizens of the Union to challenge European authorities and request changes or new community legislation. An ECI must collect 1 million signatures across the EU to be considered by the Commission.

Through its participation tools, Rennes worked for two yearswithresidents and carried out a Rennes ICE that "demands a dignified reception for immigrants in Europe."

The experience is the voice of the Ville de Rennes and Rennes Métropole team.

Rennes is a European city. It demonstrates this every day through the actions of its associations and citizens, who are mobilised to bring the European project to life in concrete terms, for the people of Rennes, and particularly for those who are furthest excluded from it. All these people, institutions and residents' groups are united within the City of Rennes' Labo Europe, whose aim is to renew the citizen debate on Europe. The Labo is part of the "Fabrique Citoyenne," which brings together all of the city's and metropolitan area's citizen participation initiatives, and benefits from the tools available within this framework.

Our ECI is the result of an unprecedented process of dialogue launched by the Labo, enabling the people of Rennes to make their voices and demands heard in Europe. For almost a year and a half, everything was done to enable the people of Rennes to have their voice heard in Europe. At the end of this grassroots approach, 12 proposals for European citizens' initiatives were put forward for local public debate, co-constructed by some 300 Rennais. The call for a dignified welcome for migrants was the clear winner of the online vote organised to decide between them in spring 2022. Over 1,000 votes were cast. This ECI is the result of a major collective effort, coordinated and supported by various associations, students and academic players, who worked together on the basis of the work of pupils from the Rosa Parks middle school in Rennes. An organising group was then set up, made up of citizens from seven different European countries, who are responsible for relaying the initiative in their own countries. The ECI

was registered by the European Commission in February 2023, and the campaign to collect signatures began in April and will last a year.

This project is an innovative experiment because the ECI was built directly by the citizens of Rennes, who had the freedom to put forward a cause that affected them personally and that they wanted to defend before the institutions, whereas this little-known form of citizen participation is generally used by major international NGOs.

The Rennes European Citizens' Initiative makes it possible to bring the voice of local residents to bear in a concrete way, from the local to the European level, showing citizens that they are being heard and supported by the city and, above all, that they have the means, at their own level, to influence European policies."

#### Comments from the jury

# Rennes is a magnificent winner of the 17th IOPD Award insofar as it meets a triple challenge:

## The articulation of the local level with the (supra)national level:

very often, we observe that the issues tackled at local level are purely micro (e.g. waste treatment or traffic plans), here we see a macro issue mobilised by the local level.

# The mobilisation of the local level in a European Citizens' Initiative (ECI):

European Citizens' Initiatives are often mobilised by organised European players to put an issue on the political agenda and initiate a campaign on the subject. In this case, it's a local authority that takes the initiative of federating at European level - a reversal of principle that's particularly important in a climate of hostility towards EU institutions.

#### Promoting a progressive theme:

in a current context marked by rejection of the Other and xenophobia, it is truly salutary to support an initiative that promotes the DIGNITY of human beings. A demand that goes totally against the grain of the media-political dehumanisation we are currently witnessing through the "migratory waves" "hordes/fluxes/tide of migrants."

- It is interesting the component of **social inclusion** at different levels, it has been done on such a sensitive issue in Europe, **migrants**, and it has been **done in a neighbourhood where there is a migrant population** I think **it is important that people who have migrated can carry out an inclusion project.** It also has a future projection: they are asking for 1M signatures so that **it can continue at a European level.** We have an example that takes the initiative to reinforce an initiative that can be European in a European context, which is an increasingly complicated issue.
- It is always really great when municipal territory goes far beyond in a very difficult context. With this experience we see that we have a real local leader in Rennes who has taken things forward they are trying to move from the local to the European level with a radiantly topical theme and this must be supported.



# Weaving Citizenship: Training and Social Support for Democracy, Participation, and Reconciliation

Municipio de Titiribí and Corporación Conciudadanía

Citizenship / Up to 50,000 inhabitants

Titiribí is located in the Southwest of Antioquia (Colombia). Made up of four townships: Sitio Viejo, La Otra Mina, La Albania and La Meseta and 16 veredas (subdivisional administrative part). It has a poverty level that reaches 23.78% and an Unsatisfied Basic Needs index of 11%.

Before the 80s, Titiribí was dedicated to the agriculture of coffee, sugar cane and coal mining, among other economic activities. Starting in the 80s, the massive purchase of land by people linked to drug trafficking and money laundering assets, the agricultural vocation and the uses of the land were changing - the land was dedicated to extensive livestock farming and the construction of recreational farms. Linked to this, there was also the creation and presence of paramilitary groups, seeking to guarantee protection of the owners and their assets, which at the time were subject to robbery and kidnapping by common crime and *guerrilla* groups that

had settlements in the region. The armed conflict generated a significant number of victims, violations of their rights, with emotional and physical consequences. This is a population that still continues to seek reparation and healing for the pain left by armed violence.

Politics in this region is characterised for being very traditional, clientelist and exclusive, led by large land-owners who have the power to buy votes and appoint mayors. Despite this context, the population of Titiribí seeks strategies of organisation and participation. An indicator of this is the number of groups, collectives and associations that exist in the municipality: environmentalists, observers, young people, women, promoters of memory and cultural heritage, among others. All of them are eager for knowledge, advice, and interested in actively participating in processes that contribute to improving their living conditions, strengthening democracy and peace.

"Weaving Citizenship: Training and social accompaniment for democracy, participation and reconciliation in the municipality of Titiribí," was the result of an alliance between the municipality of Titiribí and Corporación Conciudadanía, aiming to solve problems of social organisation and the effectiveness of citizen participation in public affairs. Public participation in Titiribí was diagnosed as weak, due to the absence of new leadership, the decay of organisational processes and the lack of knowledge about the functioning of the State and the local administration.

The objective of this practice was to increase the quality of citizen participation for strengthening local democracy through planning processes, political advocacy and the promotion of the conviviality in the Municipality of Titiribí.

The project consisted in the implementation of a Citizen Training School, to strengthen the capacity and the knowledge of leaders of all ages and genders in topics related to citizen participation, democracy, oversight, environmental management, memory and peace. This process enables them to develop a qualified dialogue and advocacy with decision makers at the local level, for the administration of their rights, the understanding and management of public affairs and the effective use of mechanisms for citizen participation and social control.

The work sessions were held every 15 days, with a didactic and participatory focus, with emphasis on dialogue of knowledge, respect for the word and dignity of the other, learning by doing. This was done through the replication of content and learning with other leaders, organisations and territories. Workshops and training meetings were held, as well as exchanges of experiences, replications by leaders and territorial visits. The project was permanently monitored and evaluated by the professionals in charge, with a participatory focus by the participants at the end of each work session.

Participants included leaders and members of organisations such as: community action boards, women, victims, environmentalists, overseers, school children, the youth council, youth collectives, community aqueducts, memory collective, as well as councillors, teachers, the peace council, and the coffee growers

committee, the Territorial Planning Council, and the Municipal Rural Development Council.

Among the results, we can highlight:

- The Territorial Planning Councils have the knowledge and tools for a good management of their functions, especially for the follow-up of the Development Plan.
- The leaders increased their knowledge about citizen participation, public management and developed social control exercises, for which they used the mechanisms for enforceability of rights.
- Women, youth and reconciliation committees have strengthened their organisations and are transcending social leadership to become proactive and involved in local public life.
- The communities are aware of and provide feedback on the memory process of the armed conflict developed in the municipality.
- The environmental collectives were strengthened organisationally and also their actions for the care and protection of water resources.

#### Comments from the jury

This experience is particularly noteworthy for its objective of creating a more active and participatory citizenship.

Above all, it is commendable that the issue of the armed conflict was taken up directly, and that the people affected by the armed conflict are one of the social sectors included in the initiative. A large number of civil society organisations are involved.

The schools and training component is to be acknowledged. In addition, the collaboration with a civil society organisation is also exceptional, because it allows it to function as a co-government and co-initiative of the municipality.

It should be noted that **the armed conflict in this region** has had a high impact, with a very traditional, clientelist and exclusionary policy, led by large landowners. This **has led to a significant number of collectives aspiring to participate and play a more active role in the decisions that affect them.** One of the innovations to be highlighted is the partnership between the municipality and the corporation, which has made it possible to increase the budget and replicate the experience.



# Integrated Land Regularisation Planning in Special Areas of Social Interest (ZEIS)

Prefeitura de Fortaleza, Administração Indireta, Instituto de Planejamento de Fortaleza (Iplanfor), Diretoria de Articulação e Integração de Políticas (DIART/Iplanfor)

Deliberation / City of more than 1,000,000 inhabitants

Fortaleza, the capital of the State of Ceará, is a city located in the Northeast region of Brazil, with a remarkable cultural diversity shaped by its history of cultural exchanges during periods marked by colonisation, trade, and cosmopolitanism, without losing its indigenous roots and customs. Its avant-garde and inclusive multiculturalism earned it recognition as a "Creative City of Design," becoming part of the UNES-CO Creative Cities Network in 2019.

Geographically, Fortaleza is a coastal city, influenced by its connection to the sea, linking it to the interior of the state. Extensive white sandy beaches, lagoons, and mangroves drive economic and environmental development policies centred around tourism. Historically, Fortaleza represented the connection between the Northeast region and Europe and the USA, attracting people from the interior of the state to the city's opportunities for life and playing a significant role in the popular struggles for social development. It was an important catalyst for the national abolition of slavery, with important figures such as the fisherman Chico da Matilde, known as the "Dragão do Mar."

In institutional terms, Fortaleza is a municipality with extensive legal infrastructure, governance, and multi-theme planning: budgetary, urban, strategic, and territorial. Its main planning instrument, the "Participatory Master Plan" of 2009, is recognised for its advancement in social inclusion and participation in





its guidelines and the design of public policies for the city's growth on democratic and participatory foundations.

Socioeconomically, Fortaleza presents contrasts between the modern and formal city: it is regulated, with public and private infrastructure available, offering a wide range of services. It also presents high human development indices and a strong inclination for commerce, and a marginalised sociourban reality where most of its population lives, characterised by low human development levels and a strong social perception of exclusion and stigmatisation.

After historic local and national struggles for the right to the city, the 2009 Participatory Master Plan of Fortaleza introduced an innovation by establishing areas of the city intended for the permanence of low-income residents and for land regularisation of social interest. These areas were called Special Social Interest Zones. In 2012, the Fortaleza Planning Institute (Iplanfor) was recreated, opening a bridge for the knowledge of these areas, the mobilisation of territorial community leaders and the participatory implementation of the established design.

The main goal of the community-based urban planning was to experience the inclusion of residents as decision-makers and urban planners, empowered in community knowledge, in the interventions and policies to be implemented or improved and in their social rights.

The aim was to broaden the understanding and the interconnection between institutional and community players, so as to enable the exchange of experiences and the politicisation of citizenship and the search for the realisation of rights, giving priority to the community's perspective.

The most striking innovation of this experience was the partnership with university institutions, which mobilised their pedagogical and multidisciplinary apparatus and territorial insertion to promote popular involvement and integration of knowledge. Thus allowing joint action focused on the priorities of the communities participating in the planning, on urban political engagement, on cultural and knowledge exchanges between actors with different profiles and on the awareness of the public actors involved in front of a new model of shared territorial management.

This experience began with the participatory production of the plans after the establishment of the Special Social Interest Zones management councils, articulating various institutional and community representations. During the experience of preparing the Integrated Land Regularisation Plans, the community planning evaluation methodology involved the validation and approval of the products prepared technically by university institutions, supervised by the Iplanfor technical team and only approved after discussion and adjustments by community players, who critically questioned and recommended reforms in the Integrated Land Regularisation Plans products.

The planning of the Integrated Land Regularisation Plans promoted the approximation and integration of various social policies: transport, health, land tenure, economic development, etc. It also displayed a multilevel approach - municipal, state and federal - to their beneficiaries, who built during meetings, visits and workshops the implementation of the "Special Areas of Social Interest (ZEIS) Policy", associated with the municipal land regularisation policy.

The community planning of the "ZEIS Policy" is monitored and supervised by participatory and community instances and mechanisms, such as the methodology for evaluating the products of the community planning, which were only approved after discussion, adjustments and recommendations by the community actors, and the Permanent Forum of the ZEIS, an instance that brings together management councils and representatives of the public administration to monitor the PIRFs and the "ZEIS Policy" in Fortaleza.

The experience had a profound impact on knowledge and data generation about the territories, valuing community knowledge, integrating insurgent planning initiatives, strengthening neighbourhood relations, politicising and empowering communities for a dignified life with full access to the benefits of urban living.

# Participatory Budget 2023-2024: Citizen Laboratories as Innovation Devices in Public Policy Management

Municipalidad de Rosario

Decision / City between 250,000 and 1,000,000 inhabitants

The city of Rosario (Argentina) is an urban centre of 178.7 km², located in the southeast of the province of Santa Fe, on the right bank of the Paraná River. It was recognised as a city in 1852 and declared a municipality in 1883.

It has a population of 1,009,037 inhabitants (2023 projection according to preliminary data from the 2022 census), 75.42% of the total Metropolitan Area of which it is the epicentre. Of the population, 52.5% are women, 47.5% are men. The average life expectancy of the population is 76.46 years. The infant mortality rate is 7.14% (9.20% the national average), with 28.09% of the population being under 15 years of age (2010 census). 49.5% of the population – considering the Greater Rosario agglomerate – is eco-

nomically active, 72% are workers or employees; 23% are self-employed; 4.5% are employers, and 0.4% are unpaid family workers. The unemployment rate is 6% (below the national average of 11%). In the Rosario agglomerate, 22.8% of households are poor, and 3.7% are living in a situation of homelessness (EPH third quarter 2022).

The "Gran Rosario" area is the most important agro-export port node in the world. Rosario is a port city, where 78% of Argentina's grain, oil and flour exports are shipped, industrial and services city for a wide region, and has great road connectivity and an international airport, in addition to railway networks for freight transportation. The area is part of the most important productive corridor in the country that extends from the city of La Plata to our town.

Rosario, Argentina, is a pioneer and international benchmark in Participation, Transparency and Collaboration policies.

For almost three decades, with the impetus of former Mayor Hermes Binner, the Municipality has been working hard to make residents feel committed to the destiny of the city, encouraging citizen participation in its government tasks.

In 2002, Rosario had its first experience of Participatory Budgeting, an innovative instance in which citizens, through the development of citizen assemblies, debated about budgetary priorities by thematic areas.



Over the years, the experience has changed, incorporating instances, diversifying the propos-

With the pandemic, with the territorial teams of each District and with the different Secretariats of the Municipality, as well as with other localities that carry out the Participatory Budget, dialogue was held to define guidelines that allow adding value to the experiences developed. It sought to enhance them with greater availability of data to decide and complement them with virtual instances that deepen the interaction between citizens and public administration.

als, and innovating in voting methodologies.

This process made it possible to design the new modality adopted by the 2023 and 2024 Participatory Budget.

The objective is to strengthen collective intelligence and design opportunities for the co-creation of projects that consider the complex social and urban problems of these times, incorporating new forms of participation based on multi-stakeholder and network, taking advantage of communication technologies and the information to achieve greater impactine achteritory with a comprehensive and strategic perspective.

The Municipal Proximity Teams, through face-to-face and digital instances, are linked with neighbours and community organisations throughout the year, gathering demands and initiatives, which are configuring the map of priorities to **develop a Bank of Ideas and a Public Proposal Bank.** Thus, from the Municipal Management the priorities considered by the residents in each District are consulted, aligning the initiatives to the axes of Government.

Subsequently, the initiatives, in an iterative process, are strengthened in the <u>Citizen Laboratories</u> in faceto-face sessions with neighbours, which take place in each of the six District Municipal Centers. These initiatives are available in parallel on the <u>Rosario Participa</u> portal, to add remote opinions. People of reference from civil society organisations; city leaders, territorial coordinators, and neighbours add concrete actions so that these projects take neighbourhood coexistence into account, are accessible, sustainable, inclusive, and with a gender perspective.

Once the projects are closed, following a feasibility analysis, they are put to online voting for four weeks to be prioritised by the residents. The seven selected projects will be executed in the first semester of the following fiscal year (one for each District, and one that will be emblematic for the entire city). Likewise, analogue polling stations are established, to guarantee the electoral participation of the greatest number of residents. In addition, residents have access to a communication tool with which they can view the progress status of the selected projects.

There is a continuity of experience that has been going on for decades, but since the pandemic, more twists have been developed. It is interesting that they were implemented beyond digitalisation, with house-to-house visits and citizen consultations (something that has occurred at the national level), the neighbourhood councils were changed with hybrid operation and became citizen laboratories; it is an interesting innovation with the scope that these new devices have.

# The turnaround of the Participatory Budget has been a good experience.

It has reinvented itself, after covid there was an effort to digitalise in general and here we see the opposite: going towards the basics of mobilisation. It is so solid and interesting that it deserves recognition.

## Programme of the Citizen University of the **Democratic Republic of Congo**

The Programme of the Citizen University of the Democratic Republic of Congo is being carried out in the province of Nord-Kivu.

This province is described as the hub of civic engagement in the country, with a dynamic youth population. An area characterised by inter-ethnic tensions and repeated wars for over two decades now. This has led to serious human rights violations, jeopardising the harmonious development of women and young people.

Young people make up the majority of the population, but they are woefully under-represented in public institutions (provincial assemblies, government, divisions, etc.) and automatically excluded from decision-making. Young women are even more affected by this exclusion. Congolese society is made up of 52% women, who represent only 13% in the national assembly and 12% in the provincial assemblies. This makes the participation of young people, and women in particular, a vital issue. A space for introducing young

people to the basics of governance and civic engagement has become a necessity. This is the rationale behind the development of the Programme of the Citizen University of the Democratic Republic of Congo.

General objective of the programme: To contribute to the civic education of Congolese women and young people so that they become real actors of change and builders of a new socio-political and economic order within their society.





#### Specific objectives

- To promote the culture of social, economic and political participation of women and young people in the Democratic Republic of Congo;
- To contribute to the emergence of women and young leaders who are passionate about becoming part of the country's decision-making bodies;
- To introduce women and young people to the methods and practices of good governance;
- To promote the emergence of new women leaders capable of defending and claiming their rights through non-violent techniques.

#### Methodological approach

- Intergenerational dialogue for the transfer of practical skills;
- Participatory pedagogy;
- Personalised follow-up in the field of commitment.

**Results:** More than 412 young people from civil society organisations (universities, associations, citizens' movements, NGOs, media, trade unions, political parties, churches, etc.) have benefited from the Citizens' University programme throughout 2022. For the current cohort, we expect to reach 1.000 beneficiaries, as the same programme is already open in the neighbouring province of South Kivu.

Some of the young people who have benefited from this programme have become leaders and managers in public and private institutions. Many of them have developed their confidence level to engage as citizens in their communities. Monitoring and evaluation: Our evaluation mechanism focuses on the collection of success stories (testimonials from participants) during and after the training period. Monitoring of indicators related to the participants' capacity for action, their level of confidence, their communication and mobilisation skills, their knowledge of good governance principles, assessment of their personal leadership, etc.

#### Comments from the jury

There are two aspects: one is democratic innovation and the other is innovation with respect to the place, the territory, the context,

when in Goma or in Kivu there is a university for women who can study in the midst of genocide, it is so audacious and there is so much courage behind it, that we have to look for these places for building participatory democracy.

- One thing is the capacity to transform on the ground and integrate people in certain conditions of human rights violations.
- The IOPD is a space that should be seen in a more open way to develop an approach that emphasises the most deserving nominations precisely because they are in more particular contexts. Having a mention for innovative practices in contexts of human rights violations would be very good and could encourage initiatives that are in more difficult circumstances.
- Promoting a democratic culture in a conflict territory is very difficult and the initiative deserves international support and recognition in particular for the attempt to generate female leadership, especially of young women.
- This JAMAA project differs from other candidate processes in that it is less about involving non-elected citizens in co-deciding policy directions, and it is more about creating a university to equip future policy-makers in a structural rather than ad hoc way. It would be extremely interesting to take a look at this university's curriculum and see how it focuses on innovative governance methodologies. If so, this project really deserves to be highlighted for its innovative aspect.

# Launch of the "Trash to Cash" Programme

LGU-Lipa City, Batangas, Philippines

Citizenship / Between 250,000 and 1,000,000 inhabitants

Lipa City is strategically located midway between the two primary international port cities of the Philippines, Manila and Batangas City. The city has a strategic location: as it is a valley located between two mountains, Mt. Malarayat and Mt. Makulot. It's in the heart of Batangas Province and Region IV. It is only about one and a half hours drive away from Manila via South Luzon Express and Southern Tagalog Arterial Road and a 30-minute drive away from Batangas City.

The ancestry of Lipa was born out of the Bornean Tribe. Their descendants later on spread towards Laguna de Bay and the Bicol Peninsula. Their presence at the site is attested by the excavations in the ancient settlements in Butong, Taal, Batangas and Calatagan Bay area in the latter part of 12th century, until the coming, Goite and Legaspi in 1570. It was influenced by the eastern civilization of India, and western civilization of Spanish Colonisation of the Philippines and the Salcedo conquest of Batangas in

1572. This led to the establishment of Malay settlements along the Taal Lake of Tagbakin inhabited by the warlike descendants of the two datus called tagalogs. In 1605, after Marshal Gabriel de Rivera received the encomienda of Bonbon, the Augustininan fathers made Tagbakin the first settlement of the Lipeños and a mission centre. The settlement was made a regular municipality in 1702. It became a city in 1947.

As of now, the City Government of Lipa in the Philippines is serving 51 out of 72 barangays (neighbourhoods or zones of the City) in waste collection. Most of the rural barangays have their own service vehicle that transfers their residual waste to the City Centralised MRF, while all urban barangays were being collected by our private hauler. The Environment and Natural Resources Office (ENRO) of the city admitted that collection of waste must be done in all 72 barangays. However, proper segregation of waste must be strictly followed to decrease the volume of wastes









generated on a daily basis. This will make the collection process lighter and more efficient.

Moreover, strict implementation of Executive Order No. 32, otherwise known as No Segregation, No Collection, No Transfer Policy must take effect immediately. This order follows the provision of RA 9003, otherwise known as Ecological Solid Waste Management Act of 2000 in which the City is mandated to lessen the volume of waste by 5% every year.

Presently, the city government through the City ENRO has an allocated budget of Php 100,000,000.00 (around1.6M€) for FY 2024, specifically for the hauling of wastes. This much can only service 51 barangays out of 72.

Prior to this project, the office of the City ENRO always received a complaint about open burning of waste that caused difficulty in breathing especially by the

children. Illegal dumping is also rampant resulting in a high incidence of dengue problem.

Trash to Cash Project is an inter-agency project of the City Government of Lipa in which waste segregation at source is properly practised in the barangays. In conceptualising the design, various sectors involved in this project were properly consulted. Wastes at source will be sorted into Recyclable/Marketable, and Residual Waste.

All marketable wastes are accepted and given corresponding points based on the prevailing market value. Whatever accumulated points of the participants they can exchange it by goods and/or items, the same with all single use plastics, provided that it is cut or shredded into a size not bigger than 1 x 1 inch. Bigger points are given to residual waste or single use plastic to properly compensate the participants in cutting those. Collected marketable wastes are brought to the recycling company or to the junk shop owner with the highest bid. All proceeds are remitted through the Trust fund. Meanwhile residual waste is brought to Republic Cement and Building Materials Inc. (RCBMI), a private company whom we had a Memorandum of Agreement with. All cut residual wastes brought to their office at Taysan Batangas correspond to a cement bag. As of now, we have 1,828 accumulated bags of cement. Based on the agreement, 1 ton of waste is equivalent to 10 bags of cement.

As of now, there are about 56,105 households benefited by this program of basic groceries and household necessities such as cellphones, laptops, printers for the use of online students (this was conceptualised during the pandemic), gas stoves, electric fans, among others.

In 2017, the Regional Government of the Azores decided to create the Participatory Budget Azores based on the assumption of a direct, voluntary and universal process, to involve citizens in decision-making through the presentation of ideas and voting. Currently, the instrument has five editions, a public investment of €4.6M, two scopes for presenting ideas − island scope (ideas with impact on only one island) and regional scope (ideas with impact on two or more islands) − and nine thematic areas.



Through a participatory process, residual and unsafe spaces were transformed into pedestrian-friendly spaces to relax and host music, art and games. The initiative encouraged community participation through street art interventions and various artistic proposals.

#### CITIZEN ACTION COMMITTEES (CAC)

Saint-Denis, La Réunion, France

The purpose of the CACs is to meet regularly to discuss possible improvements for the neighbourhood, from a cultural or solidarity point of view, or the beautification of the living environment. They are organised as working groups composed mainly of citizens, including local actors (associations, companies, etc.) and are supported and accompanied by representatives of the town hall.

TV Cultura, Brazil's leading public television channel, collaborated with the São Paulo City Council to launch "Câmara Viva" in November 2021. This innovative program, airing every Saturday morning at no cost to the city, educates the public on monitoring parliamentarians' work, researching legislators' accountability, and discussing legislative issues' societal impacts through interviews with experts and community leaders.

In 2022, the focus shifted towards organising a larger-scale event to include sectors of society typically less engaged, seeking to find new ways to encourage their participation.
