PHOENIX - The Rise of Citizens' Voices for a Greener Europe We consider this session a resounding success in terms of content, participation, and relevance. The panel commenced with Marco Meloni (University of Southampton) introducing the session's topic: the interplay between in-person and digital participation within the budgeting process (and beyond). He highlighted a shift in tendencies, moving from conflict towards collaboration and hybridisation, categorising the role of digital technologies into facilitating, enhancing, and innovating. Subsequently, he introduced the other speakers, allowing them the platform to present. Giovanni Allegretti (University of Coimbra) delved into the evolution of digital technology usage within participatory processes in the European context. He provided an overview of tools and methodologies centred on digital participation, exploring recent innovations such as artificial intelligence for public engagement (e.g., bots for detailed process organization) and gamification for increased engagement and interactivity. Igor Ferraz da Fonseca (Institute for Applied Economic Research) concentrated on digital participation in Brazil. He described and shared data on some of the most interesting and advanced uses of digital technologies in participatory processes in Brazil, focusing on the PPA at the national level and the Consulta Popular in the state of Rio Grande do Sul. He concluded by examining these







cases, offering a sort of SWOT analysis of the digitalisation of participatory processes.

Carla Bezerra (General Secretariat of the Presidency of the Republic of Brazil) provided a detailed analysis of the Participatory Multi-Year Plan, an innovative social participation process at the national level in Brazil. Her discussion included data, analysis, and reflections on this ongoing process, emphasising its results, including the involvement of more than 1.4 million citizens. She highlighted the mutual reinforcement of in-person and offline participation, demonstrating a positive path-dependency.

Lastly, the session was opened to audience contributions, adding depth to the discussions. In conclusion, it was evident that the shift towards digitalisation was influenced by various factors. Three stand out: 1) technological advancements in software and methodologies fostering online interaction, exemplified by platforms like DECIDIM, developed in Barcelona and now utilized by numerous governments and institutions worldwide; 2) the realization that technology can surmount the scale dilemma, a fundamental constraint in the initial formulations of participatory and deliberative theories that primarily focused on local-level social participation; and 3) the diffusion, circulation, and scaling-up of PB, leading to supralocal processes, particularly at regional and national levels.
